

Dear Season Ticket Holder,

Staying true to giving back to the best fans in hockey during these economic times the Colorado Eagles are offering a season ticket payment plan. The payment plan offers a flexible, convenient and secure way to pay for next years' season tickets. **There will be a \$5 processing fee applied to your season ticket balance to utilize this payment plan option; this \$5 fee will be added to your first payment.**

The payment plan will work as follows: Five installments: **first payment of 20% of your season ticket bill is charged on June 15, 2010 plus an additional \$5 processing fee.** The following 4 payments of 20% of the season ticket cost will be charged on July 15<sup>th</sup>, August 15<sup>th</sup>, September 15<sup>th</sup> and October 15<sup>th</sup>. A valid credit card will be required to sign up for the plan. The plan only applies to your season ticket bill. Once enrolled in the plan, no other steps are required. The credit card provided upon sign-up will be charged the amount due on each installment date. A reminder of your upcoming payment will not be sent out.
